Last date of receipt of application as per format given at our website : Application as per requisite format alongwith self attested photocopies of testimonials in support of Edn Qualifications and work experience be send through Registered by Post/Speed Post. The application to reach this office on or before 01 Feb 2025 (1300hours). Any application received after 01 Feb 2025 (1300hours) will not be accepted.

4. Interview Date, Timing & Venue: Candidates must reach Station HQ, Aizawl, near Thuampui Helipad at 0900hours on 10 Feb 2024 & 11 Feb 2025 for Aizawl and Lunglei respectively for the interview to be held between 0900hours onwards. Candidates must bring all the original certificates/mark sheets/degree of 10+2 & Graduation/Post Graduation/Diploma/ Course/Work Experience (Discharge Book, PPO, Service Records for Ex-Servicemen only) and one Passport size colour photograph at the time of interview. No TA/DA is admissible. Change of dates if any due to unavoidable circumstances will be conveyed to eligible candidates telephonically/by email/SMS.

5. Overlapping of Handing/Taking period and submission of Annual Property Return (Declaration of Assets) : 10 days of handing/taking over between the key appointments (OIC, MO, DO, Lab Tech, Physiotherapist and Pharmacist) at polyclinic will be carried out. The APR in respect of OIC, Dental Oftr and Med Oftr with regards to immovable & movable property will be deposited with Stn HQ Aizawl before tenaning the appt. This will be applicable for both initial appt & extension of tenure. The appt/extension letter will be issued only after submission of the said documents. The selected indls will have to undergo 10 days On the Job Trg (OJT) and obtain a Certificate from OIC Polyclinic before signing the contract. The OIC Polyclinic will obtain certificate from OIC ECHS Cell Stn HQ Aizawl. This duration of OJT will remain unpaid and counted as mandatory before assuming charge as a contractual employee.
