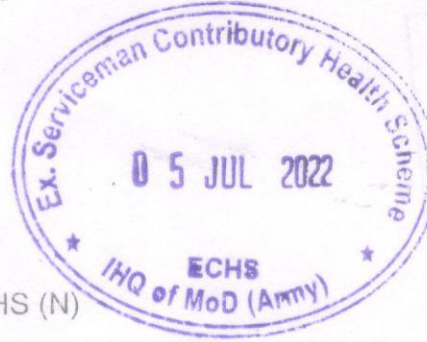

**EXECUTIVE INSTRS : GRANT OF ECHS FACILITIES TO WORLD WAR-II VETERANS/
SSCOs/ECOs AND PRE-MATURE RETIREES AND THEIR SPOUSES**

1. Numerous queries have been received by this office on the issue of reimbursement of cost of medicines to SSCOs and Pre Mature Retirees.
2. It is clarified that vide Para 3 (k) (i) of Central Org ECHS letter B/49701-PR/AG/ECHS/2019 dt 15 Apr 2019, SSCOs and Non Pensioner Pre Mature Retirees are entitled to free OPD services including medicines from ECHS Polyclinics.
3. Apropos, medicines which are prescribed but not available through the ECHS Polyclinic maybe procured by the ECHS beneficiary and reimbursement claimed in full without invoking the 50%/75% reimbursement condition.
4. However, medicines issued by an Empanelled Hospital for any IPD treatment undertaken in that hospital cannot be claimed in full since the expenditure on these medicines is included by the Empanelled Hospital in the consolidated bill. Reimbursement of the consolidated expenditure on the IPD treatment will continue to be governed by Para 3 (k) (iv) of the Central Org ECHS letter mentioned at Para 1 above.
