PREVENTIVE VIGILANCE MEASURES AGAINST PROVIDER FRAUD IN ECHS

1. Ref :-

(a) Central Org ECHS letter No B/49717-C/AG/ECHS dt 04 Dec 19 (available on ECHS website <u>www.echs.gov.in</u>).

(b) Central Org ECHS letter No B/49711-NSC/AG/ECHS/Kiosk dt 17 Aug 21 (available on ECHS website <u>www.echs.gov.in</u>).

(c) Central Org ECHS letter No B/49492/AG/ECHS/Vig dt 11 Oct 21 (available on ECHS website <u>www.echs.gov.in</u>).

2. Paragraph 6 (b) of ECHS Vigilance Guidelines promulgated vide letter under reference at Sub Para 1 (c) above, defines Provider Fraud in ECHS as 'Frauds conducted by any Private or Public Health Service Provider empanelled/utilised for providing services under ECHS'.

Fwg types of Provider Fraud Cases in ECHS have come to light from time to time :-

3.

(a) Empanelled Medical Facilities illegally deposit ECHS Smart Card of beneficiaries, do not return these in time, illegally retain photocopy of ECHS Smart Card of beneficiaries and subsequently misuse these to initiate fraudulent hospital admissions and fraudulent billings.

(b) Empanelled Medical Facilities collect ECHS Smart Cards from ECHS beneficiaries for financial considerations and misuse it for fraudulent hospital admissions, fraudulent billings and counterfeiting medical case sheets.

(c) Empanelled Medical Facilities undertake hospital admission of routine cases by indicating them to be emergency admission cases.

(d) Empanelled Medical Facilities generate duplicate bills, inflated bills, get involved in repeated overbilling and fraudulent billing for treatment not provided for the purpose of claims.

(e) Empanelled Medical Facilities get involved in fake/fraudulent hospital admissions of ECHS beneficiaries.

(f) Empanelled Medical Facilities illegally charge ECHS beneficiaries.

(g) Lack of adequate medical/paramedic staff, negligence in treatment and violation of Memorandum of Agreement by Empanelled Medical Facilities.

(h) Medical Facilities submit fraudulent documents while applying for empanelment with ECHS.

4. Various vigilance measures have been instituted to prevent, detect, neutralise and undertake punitive actions pertaining to Provider Fraud in ECHS at various echelons of ECHS through ECHS Vigilance Cells, Nominated ECHS Vigilance Nodal Officers at various echelons of ECHS and through Stn ECHS Vigilance Teams (SEVTs) at all stations in the three services. These include the following: -

(a) Tele calling by Vigilance Call Centre at Vigilance Sec, Central Org ECHS to identify suspected emergency admission cases in ECHS Empanelled Medical Facilities.

(b) Checks on unethical practices and exploitation of ex-servicemen by ECHS Empanelled Medical Facilities.

(c) Spot Vigilance Checks by SEVTs to verify cases of alleged misuse, fraud, medical negligence, violations of Memorandum of Agreement, harassment and other undesirable activities by ECHS Empanelled Medical Facilities.

(d) Various Audits, to include medical audits, hospital audits and audits of beneficiaries hospitalised in ECHS Empanelled Medical Facilities by HQ at various echelons of ECHS.

(e) Para 1 (n) (iv) of Appx E to ECHS Vigilance Guidelines promulgated vide letter under ref at Sub Para 1 (c), contains instructions that 'on admission and discharge from ECHS Empanelled Medical Facilities, in bed photos of patient be taken with hospital staff (doctor or person responsible for ECHS patients) with geotagging and time stamp, which needs to be uploaded on the BPA website with the admission intimation and claim'. 5. Disciplinary actions against ECHS Empanelled Medical Facilities found to be involved in discrepancies, frauds and so on, are reqd to be undertaken as per instructions contained in Department of Ex-servicemen Welfare, Ministry of Defence ID number 25(02)2018/WE/D(Res) dated 10 Oct 19, disseminated vide letter under ref at Sub Para 1 (a) above.

6. All ECHS Regional Centres are reqd to info this HQ about all cases related to involvement of ECHS Empanelled Medical Facilities in discrepancies, fraud, misuse, violation of Memorandum of Agreement and so on and the facilities which have been given a 'Warning', placed under 'Stop Referral' and 'Disempanelled' from ECHS, as per the format att at Appx A by 31 May 22 and subsequently on occurrence. Hereafter, copy of Warnings given to the ECHS Empanelled Medical Facilities by ECHS Regional Centres and other auths will be endorsed to Vigilance Sec, C&L Sec and Med (Empanelment) Sec of this HQ. A consolidated list of ECHS Empanelled Medical Facilities having a vigilance input against them to incl 'Warning', 'Stop Referral', 'Disempanelment' is planned to be hosted on ECHS website on a monthly basis, so that such info is utilised by ECHS Vigilance Nodal Offrs at various echelons of ECHS and SEVTs at all stns to undertake preventive and detective vigilance actions against suspected cases of Provider Fraud.

7. HQ Comds and ECHS Regional Centres are requested to forward a monthly report on Provider Fraud as per format given at Appx B.

8. This letter be put up to MG I/C Adm at HQ Comds and respective Head of Adm/Logistics in Air Force and Navy.
