**VACCINES FOR ECHS BENEFICIARY**

1. PI ref CO ECHS letter No B/49761/AG/ECHS/Policy dt 04 Jul 2017 (copy att).
2. It is reiterated that as per para 1 (iii) of ibid letter "Vaccines, in general, will be inadmissible, except Hepatitis B, Influenza and Leprovac Vaccines for high risk individuals, if recommended by concerned specialist of empanelled hospital with justification and countersigned by Service specialist of the concerned speciality".
3. However, MO/Med Spl of ECHS are auth to prescribe Hepatitis B, Influenza and Leprovac Vaccines for ECHS beneficiaries if requirement is felt by concerned treating doctor.
4. In case of NA of vaccines at dispensary of ECHS PC, OIC ECHS PC can either procure through ALC or NA can be given on prescription based on which ECHS beneficiary can purchase prescribed auth vaccine and claim reimbursement as per CO ECHS policy letter No B/49762/AG/ECHS/Medicine Policy dt 08 Apr 2019.



**NON-ADMISSIBILITY OF PREPARATIONS SUCH AS  
FOOD SUPPLEMENTS, TONICS, COSMETICS AND VACCINES**

1. As per CGHS Office Memorandum No. 593/2003-04/CGHS/MSD/RS dated 23 July 2009 issues on recommendations of an Expert Committee and Drug Controller General of India, it has been decided that -

- (i) Product manufactured/marketed as food supplement, cosmetics and ayurvedic preparations prescribed by allopathic doctors will not be admissible.
- (ii) Supply of Vitamins, Minerals and anti-oxidants will be restricted to prevalent CGHS/ECHS formulary only.
- (iii) Vaccines, in general, will be inadmissible, except Hepatitis B, Influenza and Leprovac Vaccines for high risk individuals, if recommended by concerned specialist of empanelled hospital with justification and countersigned by Service specialist of the concerned speciality.
